



Residential Electric Car Battery Charger Rebate Program

Incentive type: Residential Electric Car Charger Rebate Program – Residential Conservation Service

Eligible Technology: Energy Star Certified EV Chargers Level 1 and Level 2.

Applicable Sector: Residential – Primary Residence Only. Not open to businesses.

Incentive Amount: Account credit of 50% of the project cost up to \$250.

Maximum Incentive: \$250 per customer, per calendar year

Program Budget: Limited and capped

Restrictions:

- The rebate is for Energy Star Certified “Smart” chargers that are WIFI enabled. These chargers allow the user to program the charging time and track electricity usage.
- Customers receiving an EV Car Charger rebate must agree not to charge the vehicle between the hours of 3pm and 9pm (peak hours) in order to ensure they do not contribute to the high cost of peak power.
- HLPD reserves the right to request proof (a charge report) of charging times to verify charging outside of the 3-9pm peak power time. Customers who refuse to provide such charge report or are found to be charging during peak hours will receive a fee on their bill equal to the rebate received.
- HLPD reserves the right to perform a site visit to verify the charging settings.
- Only installations for HLPD residential customers in their primary residence serviced by the Hudson Light and Power Department. Subject to applicable restrictions in the HLPD Rate Schedules and prior agreements.

Summary: HLPD offers residential customers financial incentives to replace or install energy saving products such as Energy Star Certified Electric Car Chargers. Customers will be required to provide the original receipt, energy guide label, and proof of installation in the customer’s primary residence serviced by the HLPD.
