Is your business tax exempt?

The State of Massachusetts charges a 6.25% sales tax on non-residential electric accounts. Certain businesses are exempt from the tax, including:

-  Small businesses with 5 or less full-time employees whose gross annual income is less than \$1 million and who file an ST-13 Exemption Certificate every calendar year.
-  Industries who use electricity to manufacture tangible goods and who file a one-time ST-12 Exemption Certificate.

This month, we will mail ST-13 forms to small businesses with existing forms on file. If you think you qualify and do not have an exemption form on file with us, call for one at **978-568-8736** or visit: **www.hudsonlight.com**.
